It all began in 2009 when Founder, Chris Raine, documented his year long experiment to take a break from drinking by writing a blog. The organisation has since grown into the world's largest alcohol-focused digital health service.

Our flagship technology platform, the Daybreak app, provides free, anonymous, 24/7 peer support for people who want to change their relationship with alcohol, whether that means taking a break, cutting back or quitting entirely. Daybreak has close to 150,000 members, making it nearly 10 times bigger than Alcoholics Anonymous. Through evidence based programs, services and tools we empower individuals to achieve self-directed, peer supported change.
